BCTF News Starling Minds Mental Fitness

The BCTF is pleased to announce the return of Starling Minds' most popular initiative, the Mental Fitness program—Cultivating Calm: Mindfulness Strategies for Chronic Stress, presented by Starling Minds' Mental Fitness Coach Tara Achkar.

This is a four-week webinar that will guide you through practices aimed at nurturing inner peace and tranquility. The webinar will take place every Tuesday, from 4:00 to 5:00 p.m. (PT), February 20 to March 12, 2024.

Dual Credit Policy Discussion Draft

The Ministry of Education and Child Care has recently released a <u>dual credit policy discussion draft</u> for feedback from the field.

There are three substantive changes compared to <u>current</u> <u>policy</u>: encouraging students to take exploratory courses rather than precluding those who don't declare a future occupation; allowing for September and February funding access rather than September only; and, giving educators the discretion to include a few students in Grade 10 rather than grades 11–12 only.

Know Your Contract ARTICLE G.28 PERSONAL LEAVE

- 1. After five (5) years of continuous service in the District, the Board may consider a request for a one (1) year leave of absence, which will be renewable solely at the superintendent's discretion. Requests for such leave, without pay, will be considered on the following bases:
 - a. the requested leave period is one (1) academic year
 - b. written notice of at least three (3) teaching months is given
 - 2. Upon return to the District, the employee shall be

assigned:

- a. to the same or comparable position in the school commensurate with the teacher's qualifications and/or experience
- b. if no such position is available, to a comparable position in the District.
 - 3. A teacher shall only be allowed leave under this provision once every five (5) years.
 - 4. The request for leave pursuant to G.28.1. shall not unreasonably be denied.
 - 5. Teachers may request a short term personal leave of absence without pay.
