## Remedy

Remedy has begun to accrue this month. Teachers of classes that do not comply with the restored class size and composition provisions will become eligible to receive a monthly remedy.

### Examples of the intended use of remedy:

Booking a TTOC to co-teach and provide support within the affected classroom; to teach the class while the teacher works with a smaller group of students in need of additional support; to provide prep time to co-plan a specific unit of instruction; to provide prep for planning, assessment, or reporting.

## Know Your Contract Part-Time Teachers

**Staff Meetings:** This is not specifically outlined in the Collective Agreement (CA). Part-time teachers should attend staff meetings as long as it does not cause hardship (i.e. a non-enrolling person who works at three schools).

**Pro-D Days:** To the level of your appointment, spread over the five days; your FTE percentage of 25 working hours.

Other Non-Instructional Days: To the level of your appointment, each occurrence.
