Know Your Contract

Article G.20 - Sick Leave

Sick leave with pay is earned based on 1.5 days a month and is prorated for part-time teachers. Sick leave days are advanced at the start of the year.

If you are working in a contract or if you are on medical leave, please contact the office before you run out of sick leave days.

TTOCs who do not have sick leave days have access to 5 ESA sick days.
